NO RINSING DETERGENT FOR PROFESSIONAL USE

EASY NET is a neutral detergent for frequent use. It can be diluted by water for the daily cleaning of floors, ceramic tiles, glossy surfaces of low absorbing capacity or used concentrated for absorbing and porous surfaces, difficult dirt, persistent stains, incrustations. It is suitable for any kind of porous surface and ceramics.

Its effectiveness, the low foaminess and the low residuum are its basic main features.

No rinsing is needed. It dries quickly without leaving halos or marks and it leaves an agreeable scent of clean.

GRES PORCELAIN TILES, GLAZED CERAMICS, POLISHED MARBLES AND GRANITES, etc.

HOW TO USE

USING DILUTE. 5 to 10 grams OF PRODUCT EVERY LITER OF WATER. WASH BY MOP OR COTTON CLOTH; LET DRY IN THE AIR.

USING CONCENTRATED. APPLY THE PRODUCT TO THE DIRTY SURFACE. WAIT SOME MINUTE AND RUB BY CLOTH OR SPONGE (IF NECESSARY BY ENERGIC MECHANICAL ACTION); LET DRY IN THE AIR. IN CASE OF INTENSE DIRT IT IS SUGGESTED THE DRYING BY USING A DRY CLOTH FOR A COMPLETE REMOVAL. **NO RINSING NEEDED**

COMPOSITION

CONTAINS ANIONIC AND NON IONIC SURFACTANTS, BIODEGRADABLE >90%

CONSUMPTION

THE PRODUCT IS GENERALLY USED DILUTED IN WATER. IT CAN BE USED ALSO UNDILUTED. THE CONSUPTION CAN VARIES ACCORDING TO THE DIRT INTENSITY AND THE POROSITY OF THE FLOOR/SURFACES.

STABILITY

The product is water based: CANNOT STAND THE FROST. Do not store at temperature lower than $5^{\circ}C$ ($41^{\circ}F$) or higher than $35^{\circ}C$ ($95^{\circ}F$)
