### HOW TO APPLY IT

#### Tools



Applied by paintbrush, spraying with airless pump on the outside with a cloth or sponge.

#### Mode

Apply pure on completely dry and clean surfaces, using a paintbrush, cloth, sponge or spraying with an airless pump. Repeat the operation after 15 minutes from the first application, applying wet on wet avoiding direct sunlight on the surface. After application, do not step on the surface, for 4-6 hours.
