STAIN REMOVER for wine, coffee, nicotine, fruit, juice, tomato stains and organic stains in

tomato stains and organic stains in general

Gel stain remover expressly studied and formulated for the specific removal of stains of **organic** nature such as **nicotine**, **wine**, **coffee**, **fruit**, **juices**, **tomato** etc. It doesn't remove greasy and oily stains for which DET 1 must be used.

The stain is chemically destroyed by the gel formulation that allows a prolonged action of the active substances; the presence of wetting agents helps to remove the stains even if deeply penetrated. The product is active until the total drying.

FUNCTION

Water based stain remover, slightly foaming, for organic stains.

LINE

HOUSE MAINTENANCE

INDICATION

Suitable for the removal of every kind of organic stains not excessively penetrated in depth such as wine, coffee, nicotine, fruit, juices, tomato and organic colours in general.

MATERIALS

Recommended for all kind of porous and not porous materials.

<u>Do not</u> use on metals or materials that can oxidize easily.

HOW TO USE

Before the use shake well the bottle. Apply DET 2 on the stain to be removed and let the product works about 30-40 minutes long. Remove the residual with a clean and moist cloth. If needed repeat, one or more times, the application. Repeated applications can remove also deep stains and eliminate definitively eventual superficial halos/marks.

TEST

A preliminary test on a small, hidden area is recommended before application.

COMPOSITION

Contains sodium hypochlorite.

Avoid the contact with eyes and skin. Wear impermeable gloves (rubber or PVC).

TECHNICAL INFORMATION

The application of the product doesn't damage marbles, granites and natural stones but can locally remove some kind of superficial treatments that must be successively restored.

STABILITY

Prolonged storage can reduce the active chlorine content. Use within 6-8 month

NOTE

Active chlorine stain remover. Wear acid proof gloves. Keep out from children reach. For more information about safety see the label or the Material Safety Data Sheet.
